## “SUBARU ALPINE TEST DRIVE” PROMOTION

### TERMS AND CONDITIONS

**Promoter:** Subaru (Aust) Pty Limited (ABN 95 000 312 792) of 4 Burbank Place, Norwest NSW 2153, telephone: 02 8892 9111 (“**Promoter**”).

#### **How to Enter**

1. Information on how to enter and the Prize(s) (defined below) form part of these Terms and Conditions. Entry into this promotion constitutes acceptance of these Terms and Conditions. It is important that you read and understand these Terms and Conditions.
2. Entry is only open to residents of Australia aged 25 and over.
3. The promotional period will commence at 9:00AM (AEST) on Friday 23/06/2023 and close at 11:59PM AEST on Sunday 20/08/2023 (“**Promotional Period**”).
4. To be eligible to enter, individuals must book and complete a Subaru test drive at any participating Subaru dealership in Australia during the Promotional Period (“**Qualifying Activity**”). For the purposes of this promotion, any Subaru dealership that displays material advertising the promotion is deemed a “**Participating Dealership**”.
5. Eligible entrants must then:
  - (a) visit the Promoter’s website at [www.subaru.com.au/alpine-test-drive-promotion](http://www.subaru.com.au/alpine-test-drive-promotion) upon completion of the Qualifying Activity;
  - (b) follow the prompts to the promotion entry form;
  - (c) input the requested details, including the first name, last name, valid email address, contact phone number, postcode and name of the Participating Dealership; and
  - (d) submit the fully completed entry form during the Promotional Period.
6. Multiple entries permitted, subject to the following: (a) only one entry permitted per test drive completed during the Promotional Period; and (b) each entry must be submitted separately and in accordance with the entry requirements.
7. For clarity, incomplete or cancelled test drives will not be deemed a valid Qualifying Activity and will not be eligible for entry into this promotion.

## Prize

11. The first valid entry drawn in the Prize Draw will win the following competition prize (the "Prize"):
- Two (2) nights' accommodation for up to five (5) people at a Melbourne hotel, valued up to \$1,096;
  - Three (3) nights' accommodation for up to five (5) people at Sambuca Apartments, Mount Hotham, valued up to \$2,685;
  - 4-day Resort Entry Permit and priority parking for one (1) vehicle at Mount Hotham, valued up to \$232;
  - 3-day Lift passes for up to five (5) people (starting 22/09/2023), valued up to \$3,175;

15. The Promoter accepts no responsibility for any taxation implications which may arise from the redemption of the Prize.
16. If the Prize (or any component of the Prize) becomes unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize (or that component of the Prize) with a prize of equivalent value and/or specification, subject to any written directions from a regulatory authority.

  - (d) The loan car must be collected from Subaru Essendon, 344 Wirraway Road, Essendon Fields, VIC 3041 before 5PM AEST on Wednesday 20/09/2023 and returned to the same address before 4PM AEST on Monday 25/09/23.

- (i) The winner will be responsible for any insurance excess payable because of damage to the vehicle while in the possession of the winner. Unless expressly stated in these Terms and Conditions, all other expenses (including travel to and from the dealership, additional fuel and any tolls incurred etc.) are the responsibility of the winner.
  - (j) The winner acknowledges that they will not become entitled to any security interest in the vehicle because of winning the prize.
23. Subject to the unclaimed prize draw clause, if for any reason the winner does not take the prize (or an element of the prize) by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.

## **Liability, Indemnities and Warranties**

30. Any cost associated with accessing the promotional website is the entrant's responsibility and is dependent on the Internet service provider used.
31.
