

Subaru Australia 2022 H1 Trade Promotion Terms and Conditions

General

- 1. Information on how to enter and prizes form part of the Terms and Conditions. Entry into this competition is deemed acceptance of these Terms and Conditions.
- 2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

Who can enter

- 3. Subject to clause 4 below, entry is open to automotive businesses operating in Australia ("Eligible Business") or individuals who are Australian residents aged 18 years or over who work within the automotive trade industry and who have a valid trades card ("Eligible Individual"). Where relevant Eligible Businesses and Eligible Individuals will collectively be referred to as ("Eligible Entrants"). Publicly listed companies and employees of any publicly listed company are ineligible for this promotion.
- 4. Employees, and their immediate families, of the Promoter, associated agencies and companies, contractors or individuals are not eligible to enter this competition. Immediate family means any of the following: spouse, ex-spouse, defacto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or 1st cousin.

How to enter

- 6. To enter Eligible Entrants must make a **Qualifying Spend** during the Promotional Period (defined below) by either:
 - a) purchasing a minimum of \$3,000 (Ex GST) of Genuine Subaru Mechanical Components from a participating authorised Subaru Wholesale Parts Dealer; or
 - b) purchasing a minimum of \$7,500 (Ex GST) of Genuine Subaru Collision Components from a participating authorised Subaru Wholesale Parts Dealer.

Eligible Entrants will be awarded entries into the next Monthly Draw, the Minor Draw and the Major Draw as follows:

- For every Qualifying Spend on Mechanical Components made during the Promotional Period, an Eligible Entrant will receive one (1) entry into each draw for every \$500 (Ex GST) spent - i.e. for a spend of \$3,000 (Ex GST) on Mechanical Components, the Eligible Entrant will receive six (6) entries. For clarity, if an Eligible Entrant spends \$1,200 (Ex GST) on Mechanical Components, they will not receive any entries, unless subsequent transactions accumulate to a total spend over \$3,000 (Ex GST).

For clarity, only orders that are invoiced will be eligible for the purposes of this competition. Orders must be placed and invoiced during the Promotional Period. Qualifying Spend does not need to be made in a single transaction, but can be made up over a number of transactions during the Promotional Period. Where a Qualifying Spend is made on behalf of an Eligible Business, the entry is awarded to the Eligible Business and not the individual who placed the order for the Qualifying Spend on behalf of the Eligible Business.

- 7. Eligible Entrants must place the order through the standard Subaru Wholesale Parts Network process and provide the relevant contact details on request to be eligible to win. Eligible Entrants may only enter in their own name.
- 8. Incomprehensible, illegible, and incomplete entries may be deemed invalid.

Number of Entries permitted

- Multiple entries are permitted, subject to the following: (a) only one (1) entry permitted per specified purchase requirement; (b) each entry must be submitted in accordance with entry requirements.
- 10. Eligible Entrants must retain their original receipts, documents or tags to validate proof of purchase during the Promotional Period. Such evidence must, on request by the Promoter, be provided to the reasonable satisfaction of the Promoter, to demonstrate that the entrant has complied with these Terms and Conditions. Any Eligible Entrant found to be sharing any receipt or other proof to demonstrate proof of purchase with any other Eligible Entrant, whether or not related in any way, will have all entries invalidated and will not be able to claim a prize. If such an Eligible Entrant is awarded a prize and then found to have breached this clause, the Eligible Entrant must immediately return any awarded prize to the Promoter. The Promoter has sole discretion to determine if this clause has been breached by any Eligible Entrant. The Promoter reserves the right to request whatever documentation it deems necessary to confirm if the

Open, Close, Draw and Publish dates

- 11. The competition commences on 04/01/2022 at 12:01am AEDST and closes 30/06/2022 at 11:59pm AEST ("Promotional Period"). Entries must be received by the Promoter prior to the end of the Promotional Period.
- 12. There will be twenty-nine (29) draws for this promotion, which will take place on the dates and times in the table below. Each draw will take place at **Anisimoff Legal, Suite 5**, **Erina Plaza, 210 Central Coast Highway, Erina NSW 2250**.

- 14. Non-winning entries in each Monthly Draw will be entered into any subsequent Monthly Draw and all entries (including winners in a Monthly Draw) will be entered into the Minor Draw for their State/Territory and the Major Draw.
- 15. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The Promoter will ensure that all entries have an equal chance of winning a prize.

- 19. The total national prize pool is valued at \$91,307.32.
- 20. The total number of competition winners in this competition is twenty-nine (29), broken down as follows:
 - (i) 1 Grand Prize The first (1) valid entry drawn in the Major Draw will win a MY22 Subaru BRZ Coupe S (Manual) valued at up to \$43,393.46 with one (1) Genuine Subaru Accessory Styling Pack (including accessory government charges) valued at \$3,913.86. Total Major Prize value is up to \$47,307.32 including registration, compulsory third party insurance, stamp duty and dealer delivery charges (which may vary State by State). Additional insurance, options, petrol and all other ancillary costs are the responsibility of the winner.
 - a. - 22. A maximum of one (1) prize is permitted per Eligible Entrant (excluding SA Eligible Entrants).

Further Terms and Conditions

- 23. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 24. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence or employment) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

31. Statutory guarantees, Waiver and liability

- 32.
