### How to Enter

1. Information on how to enter, mechanics of entry, and Prize (defined below) form part of these Terms and Conditions. Entry into this promotion constitutes acceptance of these Terms and Conditions. It is important that you read and understand these Terms and Conditions.
2. The giveaway will be conducted in-person at the Promoter's event activation area at the 2025 Melbourne Motor Show.
