How to Enter

1. Information on how to enter, mechanics of entry and Prize (defined below) form part of these Terms and Conditions. Entry into this promotion constitutes acceptance of these Terms and Conditions. It is important that you read and understand these Terms and Conditions.
2. The promotion will be conducted via the Promoter's website at www.subaru.com.au/ultimate-subaru-wilderness-adventure-competition.
3. Entry is only open to residents of Australia aged 25 years or over who can travel to Perisher Valley Hotel in NSW, St Falls Resort in VIC or Subaru Alpine Retreat at Hotham in VIC between 9th - 15th August 2027 (inclusive).

6. Only one (1) entry is permitted per person.

Winner(s) Draw and Prizes

7. The draw will take place at Anisimoff Legal, L3/162 Collins Street, Melbourne, VIC 3000 on Tuesday 6 October 2026 at 11:00am (AEDT) in the presence of an independent scrutineer. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. Eligibility of Entrants and Entries

18. 26. The Promoter reserves the right to disqualify you for: (a) tampering with the entry process; (b) submitting an entry which is not in accordance with these Terms and Conditions; or (c) if you are engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from you are reserved.
27. In the event of war, terrorism, state of emergency, pandemic or any other kind of disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the promotion or suspend, substitute or modify the Prizes, subject to any written directions from a relevant regulatory



authority.

Liability, Indemnities and Warranties

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
31. Except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence) for any personal injury; or loss of damage, direct or indirect, arising in any way out of the promotion.
