



'Subaru Wilderness scavenger hunt' Terms and Conditions

Sponsor: This contest is being sponsored and administered by Subaru (Aust) Pty Limited ACN 000 312 792 of Level 3, 58 Norwest Boulevard, Norwest NSW 2153, telephone (02) 8892 9111. Any questions, complaints, or comments to be directed to Subaru (Aust) Pty Ltd.

Synopsis:

Four (4) x Subaru Wilderness scavenger hunt Flags ("**Flags**") will be hidden around each resort on each Contest Period day. Resort media will release location hints on social media. Each flag is redeemable for 1 x Subaru Wilderness prize pack ("**Prize**") consisting of AS Colour Wilderness Hoodie RRP \$67.75 inc. GST, Wilderness branded Headskinz Neck Gaiter RRP \$24.99 inc. GST and Thule 28" Cargo Duffle Wilderness RRP \$143.20 inc. GST. Total maximum Prize pool value is AUD \$5662.56 GST (being 4 Prizes per Contest Period day, across 6 Contest Period days, totalling up to 24 Prizes).

Contest venue and period:

Hotham, VIC: The Contest will take place on the following dates: (a) 25 July 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST; and (b) 23 August 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST.

Falls Creek, VIC: The Contest will take place on the following dates: (a) 25 July 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST; and (b) 23 August 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST.

Perisher, NSW: The Contest will take place on the following dates: (a) 25 July 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST; and (b) 15 August 2026, commencing at 00:01 am AEST and ending at 5:00 pm AEST.

(each a "Contest Period" and together the "Promotion Period"). The Sponsor's computer will serve as the official timekeeping device for this Contest.

Who may participate:

The Contest is open only to Australian residents. "Australian Resident" means an individual that is either:

1. an Australian citizen;
2. an Australian permanent visa holder; or
3. an Australian temporary visa holder;

during the period where the individual signs up for this contest until the period where the Prize is claimed by the individual."

Entrants must be at least eighteen (18) years of age or older at the time of entry. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for the Sponsor, its



licensees, and/or their respective parent, subsidiary, affiliated and successor companies and "immediate family members" and "household members" of such individuals, are not eligible to enter the Contest or win a Prize. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. Follow the Resort socials on event day to receive clues as to where the Flags (4 Flags at each resort) are hidden around the mountain. The individual to find one of the 4 Flags in its hidden location must take it to a participating shop on mountain on the day of event to win a Prize.

Winner selection: The individual that returns a Flag to one of the specified *on-mountain retail stores* will claim a Prize (**Please note:** At Falls Creek, Prize redemption must occur **after 11am** during the Promotional Period.) An individual may only redeem one (1) Flag for one (1) Prize across all Contest venues.
