How to Enter

1. Information on how to enter, mechanics of entry and prizes form part of these Terms and Conditions. Entry into this promotion constitutes acceptance of these Terms and Conditions. It is important that you read and understand these Terms and Conditions.
2. The Promotion will be conducted via the Promoter's website at www.subaru.com.au/turbocharged-snow-holiday-competition
3. Entry is only open to residents of Australia aged 25 years and over who can travel to Perisher Valley Hotel NSW, The Elk at Falls Creek VIC or Subaru Alpine Retreat VIC at Hotham between 1st September – 7th September 2023.

provided if winner resides outside of Canberra or Albury). If the winner is from Canberra or Albury, then the prize does not include airfares and the airfare component of the prize is not redeemable for cash;

Prize or element of the Prize of equivalent value and/or specification will be awarded in lieu subject to any written directions from a regulatory authority.

- j. All components of the prize must be taken together or otherwise are deemed to be forfeited.
 - k. Travel is subject to any government issued travel restrictions (e.g. boarder closures), booking availability and blackout periods may apply.
 - l. If the Winner and/or their nominated companions are unable to travel in accordance with the restrictions above for any reason whatsoever, the Winner shall be deemed to have forfeited the Prize and an alternative Winner may be chosen. 13. Liability, Indemnities and Warranties
